VI. Presentation: Trails+ Grant- Carl Colonius, Program Director, Outdoor Recreation Division

- New Mexico is 1 of 24 states that have an outdoor office since 2013

Q: Alison Gillete asked Harding County if they were interested, they replied that they were and wanted to learn more. Shawn Jeffrey asked about the match. Carl Colonius said it was a 2 to 1 match. He also heavily noted in kind matches and community volunteers were a good way to go. He answered that there was no match waiver for this grant. Chairwoman asked if parks were eligible and Colonius answered they are, but State parks are not eligible applicants but can be recipients of the program thru a non-profit or "friends" group. Dallas Baker asked if playground equipment was eligible. Mr. Colonius said it is not an allowable expense because it gets expensive and they want to be able to fund multiple projects.

- VII. Presentation/Discussion: Safe Routes to School-Ashleigh Curry, Safe Routes to School Coordinator, Las Cruces Public Schools.
 - Program started in 2006 to encourage kids to walk or bike to school
 - 6 E's of Safe Routes to School
 - o Education, Encouragement, Engineering, Evaluation, Equity, Engagement.
 - The Benefits
 - Physical Health, Mental Health, Improve Academic Performance, Safety, Social Benefits, Independence and Confidence, Reduce traffic around the school, and Environmental benefits.
 - What we offer
 - Bicycle/pedestrian safety education, after school bike clubs, community bike safety education, volunteer opportunities for students, liaison, safety assessment for drop off/pickup, and neighborhood walk audits.
 - Internation Walk to School Day (District Wide) 3,450 students, 1,362 adults
 - Family Bike Fiesta- 224 Students, 189 parents, 83 volunteers.
 - National Bike to School Day- 226 students, 212 parents
 - Funding

- o SRTS funded by NMDOT through September 30, 2028
- o Trails+\$50,000
- o NMDOH (\$100,000) in process

Q: Patrick Million asked if this was applicable to smaller rural communities? Ashleigh Curry said yes and anyone who is 1 mile of an elementary, 1.5 miles of a middle school and 2 miles of a high school are eligible. Ms Curry said the best thing to get started is initiate an International Walk to School Day. If you are not in walking distance, have a parent drop off spot. Ms Curry mentioned that there is a monthly zoom meeting and Patrick Million would send out the invite should anyone be interested. She also mentioned a SRTS meeting with free registration in Las Cruces happening September 4th and 5th.

- I. Update from the NERTPO Planners/Program Managers: Julie Surina mentioned that she attended the NADO Transportation Conference and encouraged entities to take advantage of the different funding opportunities New Mexico provides as some states aren't as fortunate. She also thanked NMDOT for their constant communication and support. Ms. Surina also mentioned Executive Director, Sandy Chancey, will be in attendance and present at the August meeting in Logan. Patrick Million mentioned that the Transportation in Highly Rural Area grant via the Department of Veterans Affairs is open until August 23rd and the T-Mobile Hometown Grant is open until September 30. Million concurred with Surina on the state opportunities. He stated that NCNMEDD has already acquired 2 match fund grants, and the approximate total of money brought in by that program is four times what it has spent at around \$240 million.
- II. Discussion NMDOT District IV Update- John Herrera: if you have received close-out documents, please complete them so we can get them cleared out. Time extensions for TPF projects will only be accepted if letter state that all money will be spent. The deadline for match waiver LGRF projects is July 30th. TPF awards will be shared at the NMDOT August special meeting and then shared with the group. TPF approved projects match waiver deadline is September 30th, will send out agreements and execute by end of November.

Q: Is there a budget for LGRF? Mr. Herrera said about 60 million hopefully to fund about 15-17 projects.

III. Discussion: Project Status Update (local Government Members)- Town of Clayton-Started on TPF Love's perimeter. City of Las Vegas-TPF project is about 90% complete. City of Tucumcari's 4th st project is underway and is ready to start the NMDOT aviation fuel service at the airport. Village of Maxwell congressional released for waste water lagoon. Town of Springer-TPF is complete, water is almost done. Village of Cimarron, Springer and Maxwell were awarded the Clean and Beautiful Grant. Village of Folsom is about to start TPF. Village of Mosquero was awarded the Que Linda and Clean and Beautiful Grant.
