A Resolution Adopting
The Title VI Plans of
Eastern Plains Council of Governments (EPCOG) and
Northcentral Economic Development District (NCNMEDD)

- Whereas,** The Northeast Regional Transportation Planning Organization includes the counties of Colfax, Guadalupe, Harding, Mora, Quay, San Miguel, and Union with their respective municipalities, excluding the Town of Vaughn;
- Whereas,** NCNMEDD's boundaries within NERTPO include Colfax, Mora, San Miguel counties, and their respective, incorporated entities;
- Whereas,** EPCOG's boundaries within NERTPO include Guadalupe, Harding, Quay, Union counties, and their respective incorporated entities, excluding from NERTPO the Village of Vaughn;
- Whereas,** The New Mexico Department of Transportation (NMDOT) has a Cooperative Agreement between NCNMEDD and EPCOG;
- Whereas,** The cooperative agreements state the involvement of which NCNMEDD and EPCOG will be with NERTPO and NMDOT;
- Whereas,** NMDOT has tasked EPCOG and NCNMEDD to utilize all standards of planning with the regional planning organization within the Planning Procedures Manual (PPM);
- Whereas,** The PPM requires NCNMEDD and EPCOG to adopt a Title VI Plan in accordance with federal regulations and open to public comment during the formulation of the plan;
- Whereas,** The Title VI Plan of the regional planning agencies (NCNMEDD and EPCOG) can be utilized by their respective entities in NERTPO should there be any Title VI compliance issues with NERTPO;
- Whereas,** The Title VI Plan shall remain public to all persons digitally on <http://www.rtponm.org/north-east>.


