#### I. Call Meeting to Order

Chair Vernon Lujan, Taos Pueblo, called the meeting to order at 10:34 AM.

#### II. Pledge of Allegiance

Chair Lujan called on Bret Clavio, Santa Fe County, to lead the pledge of allegiance.

#### III. Opening Prayer

Chair Lujan lead the opening prayer.

#### IV. Welcome and Introductions/Public Comments:

Chair Lujan welcomed everyone and recognized members of the public in attendance. Sara Sautter introduced herself as a representative of the Hondo Mesa Homeowners Association and noted that Todd Thompson and Marc Smith were also in attendance. Ms. Sautter noted that Mr. Smith had created a video to illustrate the issues at the intersection of NM 522 and Taos County Road B007 (vimeo.com/778758002).

Ms. Sautter provided an overview of the safety concerns and issues and listed possible solutions. She noted that B007 Los Rios Road serves 194 homes on the mesa and is directed entrance for the Bureau of Land Management (BLM) Wild and Scenic Rivers Recreation Area John Dunn Bridge over the Rio Grande River, receiving a lot of traffic over the summer, including buses with rafts and rafters.

Mr. Thompson said that the HOA is looking for support for an engineering study from the RTPO, and that the concerns had been brought to Javier Martinez, NMDOT District 5 Assistant District Engineer.

Mr. Smith noted that a nearby intersection had similar concerns regarding safety of access and there was a traffic fatality recently, with subsequent restriping to create additional space for vehicles to wait to turn onto that County Road.

Jason Gonzales, Village of Questa, noted there is another similar county road intersection on NM 522, towards Arroyo Hondo, which could be reviewed at the same time or similarly to this intersection.

Chair Lujan said that this matter could also be brought to the attention of Paul Brasher, NMDOT D5 District Engineer, as well as James Mexia, D5 Technical Support Engineer. Chair Lujan said they might have funding or resources to design passing and/or turning lanes, or school bus route funding. Mr. Thompson noted that the first mile of B007 was paved with school bus route funding, and that the biggest increase in traffic came from the BLM designation of B007 as the recreation area access road, particularly with rafting company buses.

Jason Silva, Taos County, said he was aware of some of the concerns and issues previously, and he appreciated hearing more from the residents' point of view. He said that the issues as he sees them extend from B023 to B007, which could benefit from widening and a deceleration lane. An additional consideration that Mr. Silva noted is that Taos Pueblo owns land along B007 at the intersection with NM 522, and that he would need to coordinate with the Pueblo on right of way, depending on what design options and alternatives are pursued.

Sylvia Armijo, Picuris Pueblo, asked for what the HOA was desiring at this point, whether it be a letter of support from the Northern Pueblos RPTO, or something else. Chair Lujan suggested starting with NMDOT District 5 and possibly legislative representatives like Mr. Gonzales or Ms. Ortez. Chair Lujan said that the RTPO could then provide a letter of

support. Mr. Thompson asked whether the RTPO itself requested funding, and Paul Sittig, NCNMEDD, clarified that NPRTPO is a public hearing body, and such an application would come from Taos County. Chair Lujan confirmed that Taos Pueblo would also be involved, due to land ownership.



# **IX. Federal Agency Updates**

Chair Lujan invited federal agency representatives to speak to the NPRTPO Board. Mr. Sittig stated that there were no federal agency representatives on the call and noted that Governor Shutiva also had to leave for another meeting.

# X. Presentation: Overview of Road Maintenance Options (GM Emulsion)

Fred Marquez introduced the types of pavement distress as classified by the Federal Highway Administration (FHWA), and stressed the value of the right treatment at the right time to extend the life of infrastructure, displaying the following graph:



## AGE OF PAVEMENT

Mr. Marquez noted that while roads are designed with a 20-year lifespan, without proper maintenance, a road may fail more guickly and cost much more to replace. The white arcs indicate preservation and rehabilitation efforts. He displayed some examples of work done by GM Emulsion and presented an example of a HOA putting up 50% of the roadway improvement costs, with the City of Santa Fe providing the rest of the funding. Mr. Marquez also suggested contracting with vendors like themselves who have a New Mexico state general services price agreement, and some outfits like GM Emulsion can design and build road maintenance projects, depending on the project. Mr. Marquez also offered GM Emulsion's services for project evaluation at no cost. He provided links to some resources, including FHWA's Distress Identification Manual for the Long-Term Pavement Performance Program and Pavement Interactive's Pavement Distresses webpage.

Jason Gonzales, Village of Questa, asked if they could provide an estimated cost per mile for the different treatments and maintenance options. Fred Marquez noted that there are different factors in project costs, so there's no fixed price per mile. Gabriel Martinez said that chip seal is typically half the cost of the same amount of asphalt, approximately \$10 a square yard for chipseal, compared to about \$20 a square yard for asphalt. Full depth reclamation is a lot more work and cost. Mobilization and location of materials both factor into total project costs, too.

## XI. Action: Approval of NPRTPO Transit Ranking

Paul Sittig, NCNMEDD, provided a review of the previous rating efforts, and proposed the ranking for members to review and approve. Mr. Sittig noted that in the range of possible scores, 12-15 was considered "high" and all applications were ranked "high."

The motion passed unanimously with all members present.

Chair Lujan congratulated the transit agencies on their rankings and stated his appreciation for the services provided to community members by the transit agencies.

## XII. Presentation: NMDOT TAP, RTP Motorized, Carbon Reduction Program (CRP)

Paul Sittig, NCNMEDD, stated that NMDOT staff were unable to attend, and he said he would present on their behalf. Mr. Sittig noted that NMDOT recently issued a new call for applications for Transportation Alternatives Program (TAP), Recreational Trails Program (RTP) – Motorized Only, and the new Carbon Reduction Program (CRP). Mr. Sittig noted that TAP and RTP-Motorized funds were not allocated in the previous call for projects, while CRP funding is a new federal funding opportunity.

#### Funding by program:

FFY 2024 Transportation Alternatives Program

- Population 50,00 to 200,000: \$550,019
- Population 5,000 to 49,999: \$783,634
- Population less than 5,000: \$1,650,289
- Available for any area (flexible funding): \$809,485

FFY 2024 RTP-Motorized Only: \$304,786 total, statewide

Carbon Reduction Program (additional funding is available to major metropolitan areas)

- Population 5,000 to 49,999: \$1,964,463
- Population less than 5,000: \$2,176,8388
- Available for any area (flexible funding): \$4,885,946

In-kind contributions are available as an option for meeting the local match. However, in-kind contributions must be approved by the NMDOT prior to execution of the funding agreement (outlined in T/LPA Handbook Chapter 2 - Agreements) and should be discussed at the feasibility meeting.

Examples of in-kind matches include:

- Donations of funds, materials, services,
- Agency force account,
- Right-of-way acquisition, and
- Utility relocation.

The local match may also be fulfilled through a combination of cash and in-kind contributions. All in-kind contributions must be quantified, tracked, and reported throughout the project just as matching funds would be.

All 5 certifications (Environmental, ROW, Utilities, Railroad, ITS) are required when:

- The Project has Federal Funding in ANY phase.
- The Project required Federal Actions, i.e.; ROW acquisition of Federal Lands, etc.
- The Project is within or crosses NMDOT Right-of-Way.

The projects that are funded with 100% State and Local funds are also required to get all 5 Certifications when the following conditions are met:

- The Project required Federal Actions, i.e.; ROW acquisition of Federal Lands, etc.
- The Project is within or crosses NMDOT Right-of-Way.
- They Project is funded with LGRF, MAP, CAP, Capital Outlay and the agreement is executed for State Fiscal Year 2020/2021 or Prior.


Projects that are funded with the state Transportation Project Fund (TPF) funds and DO NOT meet the conditions above will not be required to obtain the 5 certifications. The local entity will be required to consult with NMDOT Environmental section in order to determine the local entities level of effort to comply with Federal/State/and Local laws.

Mr. Sittig noted that while NPRTPO has previously set their own RTIPR scoring criteria, NMDOT also has their own scoring criteria for the different programs.

NMDOT TAP & RTP Scoring Criteria:

- Planning (6 points)
- Economic Vitality (3 points)
- Safety and Security (3 points)
- Accessibility and Mobility through Integration and Connectivity (3 points)
- Protection and Enhancement of the Environment
  - Promote environmental, energy conservation and reduce green-house gas emissions (3 points)
  - o Improve quality-of-life for residents (3 points)
  - Achieve community's land-use goals (3 points)
- Efficient System Management (3 points)
- System Preservation (3 points)
- Equity (3 points)

Total: maximum of 33 points



- Planning (3 points)
- Public Involvement (3 points)
- Climate Change and Sustainability (6 points)
- Safety (3 points)
- Complete Streets & Accessibility (3 points)
- Connectivity (3 points)

Total: maximum of 24 points

#### Penalties:

Mr. Sittig presented a schedule he devised for NPRTPO, to meet NMDOT's fixed deadline of March 10, 2023, for RTPO staff to submit final, ranked applications.

Jan. 11, 2023 - Regular NPRTPO meeting, discuss rating and ranking

Jan. 16, 2023 - PFFs, PPFs, and Applications due to RTPO planner

Jan. 18, 2023 - RTPO planner schedules PFF meetings with RTPO staff, NMDOT liaison, District, Enviro., NMDOT TLPA Coordinator, and responsible charge

Feb. 1, 2023 - Regular NPRTPO meeting, review and approve rating and ranking structure

Feb. 24, 2023 - Deadline for District 5 to return signed PFFs to RTPO staff

March 1, 2023 - Regular NPRTPO meeting, rating and ranking applications, update RTIPR

March 3, 2023 - Complete applications due to RTPO planner, RTPO planner confirms completeness

March 10, 2023 - Applicants must have Title VI and ADA Plans/ Policies approved by NMDOT Title VI and ADA Coordinator before final application submittal

March 10, 2023 - Deadline for RTPO planners to upload complete applications to NMDOT's FTP site

Brett Clavio, Santa Fe County, noted that some entities had not received funding in prior years, and asked about more equitable distribution of funds. Mr. Sittig noted that the RTPO is the first body to rate and rank projects, before submittal of applications to

NMDOT, where there will be subsequent selection committees for each program. Chair Lujan stressed the importance of the application submittal deadline of January 16. Los Alamos Candyce O'Donnell also stressed the criticality of the ADA and Title VI plans, as are required for local public agencies (Tribes are exempt but encouraged).

Keith Wilson, Los Alamos County, asked which years are being funded. Mr. Sittig confirmed that TAP and RTP Motorized are for FFY 2024 but said that it is likely that CRP is for FFY 2024-2026, but he would confirm this with NMDOT and loop back with members. [Update: TAP and RTP-Motorized are for FFY 2024; CRP is FFY 2024-26]

- CRP/TAP/RTP (Motorized) Application see Appendix I
- Buy America Acknowledgement
- **Resolution of Sponsorship** indicating 1) proof of match, 2) budget to pay all project costs up front (funding is by reimbursement), and 3) acknowledgement of maintenance responsibility see Appendix IX; *alternatively*, an official letter signed by the entity's chief executive or official with budget authority, indicating all of the same, may be submitted in lieu of a resolution.
- Letter(s) of support regarding right(s)-of-way from all entities whose right-ofway/jurisdiction comes into contact with the project; this requirement only applies when a project is not located entirely within the jurisdiction of the T/LPA. The letter(s) must also address which entity will take on the maintenance responsibility of the proposed project.
- Basic map of project location (not required for non-infrastructure projects)
- Any additional documentation in support of scoring factors. For planning documents, include only the cover sheet and relevant pages. Highlight or indicate any relevant information.

On the application checklist, Mr. Sittig noted that the Buy America Acknowledgement is a new element. He asked Bryce Gibson, NCRTD, to speak to his experience with this requirement. Mr. Gibson said that is relatively simple, requiring a signature on the acknowledgement, and that your contractors are aware of and can comply with the Buy America standards for materials. Chair Lujan noted that the new Buy America requirements expanded from steel to all materials, including signage that may include pressed materials.

Mr. Gibson asked if there is any guidance on how much might be awarded for CRP. Mr. Sittig said he wasn't sure about this and would ask NMDOT and follow up.

## XIII. Discussion: CY 2023 Meeting Dates, Topics

Paul Sittig, NCNMEDD, noted that given the time in the meeting, he would bring the  $^{L^{\circ}}$  item back next month.

#### **XIV. NMDOT Updates**

District 5 – Amanda Niño, NMDOT, reminded everyone of the time extension deadline of December 9, 2022, and Dec. 31, 2022, to close out projects.

Mr. Sittig noted that neither Planning nor the Tribal Liaison were able to attend, and they had not provided him with any updates for the members.

## XV. NPRTPO Planner/Program Manager Updates and Announcements

Mr. Sittig said he had no major updates beyond the call for TAP, RTP Motorized, and CRP funding.

## XV. Member Input on Training and Presentations for NPRTPO

Chair Lujan asked the members if they had any requests for presentations or trainings. Jason Gonzalez, Village of Questa, asked for more in-person meeting attendance, and looked forward to meeting members. Chair Lujan said he would continue to encourage that but noted that there are increased cases of COVID-19, RSV, and the flu, which may make members more hesitant to attend in person. Lt.
