Q: Clay Keisling, Union County-People coming from Texas see a small New Mexico True sign entering town. Is it tourism or the gateway monument policy that could help expand this? And is there a cutoff on the survey? A: We are working with DOT and tried reaching out to tourism. Tourism should manage those gateways but DOT ROW could have a say as well. The survey will end in the next couple of weeks. Q: Jason Phillips, Raton, -Kudos to DOT on this project and glad it is your organization that is doing it. The branding strategy for Raton we are very happy with. Q: Dallas Baker, Mosquero: We have some murals along our main street. Is this an opportunity to get sealant in order to preserve them? Would graffiti removal be a part of this? A: The plan does not carry any funding with it. We are creating the rules for how projects will become eligible for funding. I will take the graffiti issue back to the team.

#### VII. Presentation/Discussion: NCNMEDD and EPCOG on CEDS Update

Felicity Fonseca, NCNMEDD, gave an overview of CEDS with support from Vincent Soule, EPCOG:

- CEDS provide a guide on investments in the region
- NCNMEDD is updating theirs this year with a goal of final product in August 2025
- EPCOG is to be updated year 2026
- CEDS identifies needs and challenges in regional and local economies.
- It is a guide for EDA. EDA will ask if the project is aligned with the regional CEDS.

**Q** (from Felicity Fonseca, NCNMEDD): What is going well in your community? **A**: Julie Kulhan, Angel Fire,: we are completing projects in a timely manner. Stephan Salas, Quay County: investment has helped everyone when projects can be done. **Q**: How have transportation investments affected economic development? **A**: Clay Keisling,: We've increased the main street to 4 lanes. In the summer a lot of Texans come through and spend a lot of money. John Romero, Mora County: improvements to 518 have helped people come through to stop and spend money. Million, NCNMEDD: is EV charging a way to keep people in town? Clay Keisling: we have been talking about that and a grocery store in town installed a Tesla charging station. People stop, spend some money in the store. **Q**: What are transportation



challenges in your community? **A:** Julie Kulhan, Angel Fire-Raising match fund requirements. Shawn Jeffrey-not getting enough money to complete a project, having to phase it for so long.

- VIII. Update from the NERTPO Planners/Program Managers: Julie Surina mentioned EPCOGVS7 is currently considering a Safe Streets and Roads for All application. Patrick Million mentioned the New Mexico River Stewardship Program and the Jemez Pueblo Pedestrian Safety workshop.

We will be reaching out to counties for CR verification next month. We are finishing support letters for the TPF and will be writing comments on the PFFs.
